

## Terms & Conditions France

**Supplier: Hertz**

**Type of car rental: optional airport/airport**

**Season: winter 2018/2019**

### **INCLUDED IN THE RENTAL RATE**

- UNLIMITED MILEAGE
- AIRPORT SERVICE CHARGES
- REFUND OF THE ACCIDENT PROCESSING FEE
- LIABILITY INSURANCE: amount of cover: EUR 7,5 mio. for personal injury and property damage
- CDW INSURANCE (damage to the rental car)
- TP INSURANCE (theft protection)
- REFUND EXCESS: In case of damage and / or theft, the rental company can charge a deductible. You pay this amount on the spot and you will be reimbursed by Sunny Cars after returning home. It is therefore not necessary to purchase an extra insurance locally.
- WINDOW-TYRE-UNDERCARRIAGE-ROOF COVERAGE: In case of damage you will pay the amount locally to the rental company and Sunny Cars will refund this after returning home. It is therefore not necessary to purchase an extra insurance locally.
- VLF (VEHICLE LICENSE FEE): included

### **IMPORTANT ADDITIONAL RENTAL INFORMATION:**

- PICK UP OUTSIDE OFFICE HOURS: only on request possible at airports, the charges will be provided upon confirmation.
- DEPOSIT: Credit Card on drivers name is obligatory. Visa/Mastercard Debit card also accepted, but only possible when the main driver can show a valid credit card in their name.
- DRIVERS LICENSES: Each driver must have been in possession of valid drivers license for at least 1 year. For the following vehicle groups you must present a valid national driver's license held for at least 3 years: DN, FC, HB.
- ALCOHOL TESTERS: From 01.07.2012 it is mandatory to have 2 alcohol testers in the car driving in France. The driver himself is responsible to have these in their car. Please let the car rental company advise you at pick up. From mid september the rental company will provide 1 test per rental car. When the test is missing when you return the car, the rental company will charge you € 5. If you need more tests, the rental company will sell them for € 2 each. At gas stations and pharmacies they offer the testers for ± € 2 each. From 01.11.2012 the police will be giving fines if the driver doesn't have a tester with him.

- **MINIMUM / MAXIMUM AGE:** Minimum age is 25 years. There is no maximum age.
- **UNDERAGE SUPPLEMENT:** for underaged drivers between the ages of 21 and 24 there is a supplementary charge of € 37,13 (incl. taxes) per day with a maximum charge of € 445,54 (incl. taxes) per rental.
- **ADDITIONAL DRIVERS:** are possible with a fee of € 8,33 per day, max. € 41,66 per additional driver per rental.

Driving of the rental vehicle by persons not registered at the rental agreement is strictly prohibited; otherwise the insurance expires.

- **MAXIMUM RENTAL PERIOD:** per contract is a maximum of 30 days.
- **EXTENSIONS:** NOT possible! customer has to arrange and pay this locally!
- **FINE ADMINISTRATION FEE:** for every fine the vehicle fleet provider receives you will be charged € 20 administration fee, besides the normal fees for the fines.

## **ACCESSORIES**

- **BABY SEAT** (until 11 months): on request only € 38,50 per rental
- **CHILD SEAT** (until 4 years): on request only € 38,50 per rental
- **BOOSTER SEAT** (until 10 years): on request only € 11 per rental
- **GPS:** Only on request possible for € 17,49 per day, € 84 per week, max. € 157,70 per rental period.  
One way with GPS: EUR 50
- **WINTER TYRES:** on request only possible for € 25 per day (max. € 200 per rental period). Only possible between 15.11. - 31.03 and only at rental locations in snow areas.
- **SKI RACK:** on request available for cat. BB or FV with extra costs: 1-4 rental days € 37,50 per rental; 5 days and more for € 40,83 per rental. Only available between 15.11 - 31.03
- **SNOW CHAINS:** on request available for cat. DB or FV with extra costs: 1-4 rental days € 37,50 per rental; 5 days and more for € 40,83 per rental. Only available between 15.11 - 31.03
- **WIFI:** on request only possible for € 9,99 per day, max. € 69,93 per periode
- **DELIVERIES:** on request only possible with extra costs quoted ex EUR 15 (excluding tax) each way plus EUR 1,62 per km.
- **ONE WAY RENTALS:** only on request possible with extra charge of 50 EUR pl. local tax for cat. YB, AB, BB and DB possible. A One Way Fee of EUR 152,45 (excluding tax) will be charged for all other categories. One way with GPS has extra charges of EUR 50. One way within the same city free of charge
- **CROSSING OF BORDERS:** only on request possible!

INFORMATION ABOUT THE VALUE OF CDW & TP EXCESS, WHICH YOU CAN RECLAIM FROM SUNNY CARS:

- CDW - COLLISION DAMAGE WAIVER: € 1000 for cat.YB, AB; € 1400 for cat. DB, DBA, DC, DR, FV; € 1.800 for cat. FW; € 1.00 for cat. WB Please read the terms & conditions to reclaim the excess.
- TP - THEFT PROTECTION (in EUR): € 1000 for cat.YB, AB; € 1400 for cat. DB, DBA, DC, DR, FV; € 1.800 for cat. FW; € 1.900 for cat. WB Please read the terms & conditions to reclaim the excess.

**OPTIONAL INSURANCE:**

- PAI (Personal Accident Insurance): to be accepted locally for € 34,80 per rental period according to the conditions of the country where rental takes place
- It is not necessary to buy any additional insurance (DVW, Super CDW, EXW) for the excess waiver coverage and damages to windscreens, tyres, the underside or roof of the car. Should you decide to take these optional insurances, Sunny Cars will not refund the charge.
- OFFICE HOURS: The opening hours differ. Please inquire at time of reservation or upon arrival at vehicle fleet provider.
- RETURN OF RENTAL VEHICLE: please inquire locally if the vehicle must be returned full or empty.
