

Terms & Conditions Switzerland

- **SUPPLIER:** Hertz
- **TYPE OF CAR RENTAL:** Car optional airport/airport
- **SEASON:** Winter 2015 - 2016

INCLUDED IN THE RENTAL RATE

- UNLIMITED MILEAGE.
- AIRPORT SERVICE CHARGES.
- LIABILITY INSURANCE: amount of cover: unlimited for personal injury and property damage.
- CDW INSURANCE (damage to the rental car).
- TP INSURANCE (theft protection).
- REFUND EXCESS: In case of damage and / or theft, the rental company can charge a deductible. You pay this amount on the spot and you will be reimbursed by Sunny Cars after returning home. It is therefore not necessary to purchase an extra insurance locally.
- WINDOW-TYRE-UNDERCARRIAGE-ROOF COVERAGE: In case of damage you will pay the amount locally to the rental company and Sunny Cars will refund this after returning home. It is therefore not necessary to purchase an extra insurance locally.
- SWISS ROAD USING FEE: CHF 4,20/per day + tax.
- WINTERTYRES: included.

IMPORTANT ADDITIONAL RENTAL INFORMATION:

- DEPOSIT: Credit card in renters name obligatory.
- PICK UP OUTSIDE OFFICE HOURS: on request only with costs CHF 50.
- DRIVERS LICENSES: Each driver must have been in possession of valid drivers license for at least 1 year.
- MINIMUM/MAXIMUM AGES: 25 years.
- UNDERAGE FEE: 19-24 years CHF 13,90 per day (max CHF 139) + tax.
- ADDITIONAL DRIVER: CHF 13,90/driver/day+tax (maximum CHF 139,-/driver/rental+tax).
- HOTEL DELIVERIES: only on request possible with extra cahрге of CHF 50+tax. This service is possible for hotel on cities with location supplier.
- ONE WAY RENTALS: available within Switzerland on requestby minimum of 3 rental days. An extra cahрге will be applied for Bellinzona, Brieg-Glis, Crans-Montana, Gstaad, Locarno, Lugano, Martigny, Sion, St. Moritz, Verbier, Zermatt at CHF 120+tax!
- CROSS BORDER: on request only possible for cat. YB, DB, FB, DG, VB, FC, ȳȳBB, DF to the following countries: Andorra, Austria, Belgium, Czech Republic, Croatia, Denmark, Finland, France, Germany, Gibraltar, Hungary, Italy, Liechtenstein, Luxembourg, Monaco, Netherlands, Norway, Poland, Portugal, United Kingdom, Ireland, Northern Ireland, San Marino, Spain, Slovakia, Slovenia, Sweden.

IMPORTANT ADDITIONAL RENTAL INFORMATION:

- BABYSEAT: available for babies up to 11 months: CHF 63,90/rental+tax.
- CHILDSEAT: available for children up to 4 years: CHF 63,90/rental+tax.
- GPS: only on request available. 23,55 CHF/day or 138,90 CHF/week, CHF 227,80 per month.
- SNOWCHAINS: charge CHF 10/day+tax (maximum CHF 210/rental+tax).
- ROOF RACK: not available.
- SNOW CHAINS: only on request available CHF 10/day+tax (maximum CHF 210/rental+tax). possible from 15.11 - 31.03.
- SKI-RACK: only on request CHF 54,65/rental plus tax. Not possible for minivans.
- BICYCLE RACK: not available.

INFORMATION ABOUT THE VALUE OF CDW & TP EXCESS, WHICH YOU CAN RECLAIM FROM SUNNY CARS:

- CDW - COLLISION DAMAGE WAIVER: CHF 1.500; for cat. YB, DB, DG, BB, DF; CHF 2000 for cat. FB, FC; CHF 3000 for cat. VB, WB, HGN.
- TP - THEFT PROTECTION: CHF 1.500; for cat. YB, DB, DG, BB, DF; CHF 2000 for cat. FB, FC; CHF 3000 for cat. VB, WB, HGN.

OPTIONAL INSURANCE:

- PI (Personal Accident Insurance): to be accepted locally for CHF 6,50/day+tax, for cat. VB+WB CHF 11,15.
- It is not necessary to buy any additional insurance (DVW, Super CDW, EXW) for the excess waiver coverage and damages to windscreens, tyres, the underside or roof of the car. Should you decide to take these optional insurances, Sunny Cars will not refund the charge.
- MISCELLANEOUS INFORMATION: Above mentioned costs for extras like baby and childseats, additional drivers etc. are exclusive of local taxes. Local taxes and costs for extra's are subject to change and therefore cannot be refunded by Sunny Cars.
